2. Continuing Business

a) "EF safety tips" to the beginning of the meeting. (Forrest Masters) https://www.eng.ufl.edu/safety/safety-moments/

Forrest shared with the Council several videos on safety from the University of Florida, and invited the Council to review them for any information that might be helpful in their facilities.

b) NHERI-wide meeting with researchers (NHERI Impact 2020)-Update (Dan Cox).

Dan Cox reported to the Council that:

- the Ad-Hoc Organizing Committee was together and with good representation across NHERI wide activities and stakeholder groups.
- Hotels in VA were contacted and entered in negotiations to secure venue and date of the 2-day meeting. Dates being considered now are in 2021.
- The NCO will submit a proposal requesting funds for the meeting to NSF. The goal of the meeting is to share NHERI research information (use of NHERI), NHERI Science Plan, and impact from the work in the form of code changes, standards, etc. Highlighting projects funded by NSF and other agencies. Program managers from NSF and other agencies funding NHERI work will be invited.
- Types of activities will include town hall meetings, panel sessions, and plenary (with invited talks) and concurrent sessions.
- Invitations to, and partnering opportunities with other centers, such as the NIST resilience center, and other organizations such as EERI will be explored.

Action Item: Dan Cox will contact Heidi from EERI and an invitation to join the researchers meeting and to discuss future opportunities to partner.

 - Ellen, Lori and Sanjay felt that the metrics for the facilities are not easily transferred to non-lab facilities CONVERGE, SimCenter and DesignSafe. Input from the Council is that the metrics of these non-lab facilities still need to convey information about users, and use of expenditures.
 - Joy indicated that metrics for labs and non-lab components of NHERI should convey who are the users, and utilization in a way that is clear and easy to understand for NSF
 - Key questions are: (1) Is NHERI being utilized and (2) How is it being utilized.
