### 3. Continuing Business

- a) Update NHERI Researchers Meeting. (Dan Cox and Julio Ramirez) (10 minutes) Julio updated the Council on the status of the planning and meetings with NSF to collect input. Plans to convene the TG sometime in July and report at the next Council meeting.
- b) Upcoming NHERI Booth Deployments (Dan Zehner, 5 minutes)
  - i. 17WCEE (Sendai, Japan September 20, 2021 to November 2, 2021, 2021) (in-person conference will be held at the venue for 6 days from Sept. 27 to Oct. 2, 2021, the on-line conference period will be extended to one week before and one month after the conference, from Sept.20 to Nov. 2, 2021, as an "Extended conference period (ECP)")

    Dan Zehner updated the Council on the planning for the virtual booth and asked for feedback on a request from the organizers for one short (2-3 min.) video about the organization. The Council concurred that the NSF/NHERI produced video was the best option. The video will be shared with the organizers of the 17 WCEE and the link to the video is:

- c) Collection of NHERI-wide metrics (Dan Zehner, 5 minutes)
  Dan Zehner updated the Council on the collection of the metrics of impact now being reported on a six-month basis. He will distribute the latest document with the information on the metrics for the components to report on.
- d) DesignSafe: EF Publish your Data Events and external evaluation process (Ellen Rathje, 10 minutes)
  Ellen reported on activities related to data and reuse. In particular, she pointed to
