- a) Update NHERI Researchers Meeting. (Dan Cox and Julio Ramirez, 10')
 Julio updated the Council about the Summit status. Registration is open via the

Julio informed the Council about opening talks with KOCED from South Korea to explore collaborations and asked for input on two specific areas. Other input is welcomed as well. The questions are:

- 1. Would there be interest in joining a global network of facilities available to industry for testing?
- 2. How about participation of other U.S. Laboratories not in NHERI in only NHERI is invited to join?
